### **BUSINESS DEVELOPMENTS**

**ACT 2 Technologies**, a firm that manufactures equipment and components used in the reclamation of water, has announced plans to acquire a 3-acre lot in the Spaceport Commerce Park in Titusville for the construction of a new manufacturing operation. The company, which originated in Ft. Lauderdale, anticipates a total investment of more \$2 million, with an initial building footprint of 7,500 sq. ft. The project was made possible with assistance from the North Brevard Economic Development Zone.

Using a closed loop remediation method, the company's patented equipment items allow for water purification and water reuse in toilets and irrigation systems, particularly in marine-based environments. ACT 2 products can be found on luxury liners, sea-based oil rigs, and marine observation vessels. The company's wastewater discharge systems have also been used in restroom facilities at U.S. Army bases and installations. **8K Solutions**, a company that designs and integrates audiovisual systems for amateur and professional sports teams, recently acquired a 26,000 sq. ft. facility on Grissom Parkway in Titusville's Spaceport Commerce Park. The purchase will permit the company to consolidate its administrative, assembly, and warehousing operations in one location, while also providing the company with space to add prototyping shops and demo spaces. The firm, led by local entrepreneur Dan Aton, provides video services for sports teams and coaching staffs, thus helping to improve player skills and preparation for competition. The company, which now employs more than 10 people, has worked with the Orlando Magic, the University of Florida, the U.S. Army, the New York Giants, and the reigning college football champions, the University of Alabama. As recently reported in the <u>Orlando Business Journal</u>, California-based *Space Exploration Technologies* (*SpaceX*) is planning to occupy a 52,000 sq. ft. building at Port Canaveral in North Brevard to service and refurbish elements of its Falcon 9 rockets; the company may develop a second building on an adjacent parcel. The move is the result of SpaceX's current practice of retrieving the rocket boosters on barges at sea, and needing a facility in close proximity to the port to improve the speed and efficiency of re-processing the stages. In July, the company announced that it would build two more landing pads at Cape Canaveral to land three boosters simultaneously from its Falcon 9 Heavy rocket; a launch of the Falcon 9 Heavy may take place before the end of the year.

SpaceX, founded by tech entrepreneur Elon Musk in 2002, is a commercial space company that designs, manufactures, and launches advanced rockets and spacecraft. For more information on the company, visit <a href="https://www.SpaceX.com">www.SpaceX.com</a>.

Lockheed Martin - Astrotech Space Systems is nearing the completion of final processing work in its Titusville facility for the National Oceanic and Atmospheric Administration (NOAA) next generation weather satellite, known as the Geostationary Operational Environment Satellite, or "GOES-R." A launch date at Cape Canaveral for deployment of the satellite is expected in November. The GOES-R is expected to provide higher-resolution images of weather patterns and severe storms five times faster than currently available from existing NOAA orbital systems, which should increase the accuracy and reliability of weather forecasts. The satellite system will also improve hurricane tracking and intensity forecasts, while also increasing thunderstorm and tornado warning lead times.

### TIMBER INDUSTRY IMPACT ON NORTH BREVARD

Although tourism and the space industry are important to the economy of Brevard County, the area is also impacted by an industry that has great importance to the state of Florida – the timber and forestry products sector. According to the Florida Forestry Association, forests cover half of the state's land area, with most of the timberland situated north of Orlando, for a total of 17.3 million acres. More than 5,000 products are made for timber, items ranging from furniture to pharmaceuticals. And the timber industry is booming; according to a recent article in the <u>Orlando Sentinel</u>, prices for lumber have steadily risen in recent years, as timber mills add employment and expand production. <sup>1</sup> [For information on forests in Florida, visit www.floridaforest.org.]

# **NASA SPINOFF:** Laser Vision Helps Hubble

When *Space Shuttle Atlantis* (now on permanent display at the *Kennedy Space Center Visitor Center*) was preparing for its mission to repair the Hubble Space Telescope in 2009, NASA requested bids from optics companies to replace the misshapen mirrors on the telescope. *AOA Xinetics*, now a division of major Brevard County employer *Northrup Grumman*, created a tool to detect mirror defects, which it incorporated into a commercial 3-D imaging system. Among its applications is a package-detection device now used by all major shipping and cargo companies – including those accessing Port Canaveral.
