### When & Where

The event hours are from 7:00- 10:00 p.m. on Thursday, July 4, 2019.

**PLEASE NOTE: Fireworks will be launched from Marina Park, vendors and activities will be set up in Sandpoint Park!**

- A Vendor Map will be made for the event. Please provide us with detailed contact information, including e-mail, so that we can provide you with a map prior to the event.
- Please make sure you indicate the COMPLETE length of your trailer/display so that we may allow enough space.
- You must set up in the vendor location assigned to you. Spaces are assigned on a first come first served basis. If you are not in the correct location you may be asked to move. You will also be asked to stay in your assigned space to pass out materials, free items or gather signatures. ***There will not be any roaming about the event.***
- Each Vendor is responsible to bring all of the equipment they might need for the evening. This includes but is not limited to a tent, table, chairs, generator and electrical cords.
- **Timeline:**
  - 4:30 p.m.** – Vendors will be allowed access to the set-up area at this time. Access to the park should be on Max Brewer Causeway.
  - 6:00 p.m.** – All vendors vehicles should be removed from the event area and parked in designated areas. **We will not allow any vehicle traffic through this area until the event ends at 10:00 p.m.**
  - 7:00 p.m.** - Red, White and Boom Over North Brevard begins!!! All vendors should be set up and ready to go.
  - 9:15 p.m.** – Fireworks!
  - 10:00 p.m.** – the event officially ends. Vendors should immediately begin tearing down and cleaning up. In order to allow event volunteers to get home in a timely fashion, we request that vendors be prepared to depart within one hour of the event end time.
